- Multiple opportunities each month for education and training, including webinars, a successful inperson meeting, a new virtual unconference, and regular networking calls;
- Publication of several **research** reports, including the highly anticipated 2023 *State of State Records Report*;
- Tireless advocacy efforts for the government archives profession, including the successful confirmation
 of the first female Archivist of the United States, a powerful Archives on the Hill day, and collaborative
 work on a number of archival issues; and
- Work towards establishing a sustainable and excellent future for CoSA through standardization of administrative practices, more efficient workflows, and a dues assessment process.

All of this could never be accomplished without the dedication of our Board of Directors and many committee members who contributed more than 1000 hours to our mission as well as our CoSA staff and project contractors who work to fulfill our members' vision for the organization. We are particularly thrilled with the hiring of long-time contractor Rebecca Julson as our Community Coordinator and second staff person.

Now more than ever, CoSA needs to lead the way of supporting the non-partisan work of government archives. We have much in store for 2024, and we look forward to the path ahead alongside our members, partners, and friends.

CoSA's education and training programs respond to member needs and focus on improving state and territorial archival programs, no matter their size or level of operation.

CoSA's education and advocacy programs rely on data about the state and territorial archives community to underpin funding proposals, awareness building, and advocacy. CoSA is seen as the source of reliable information about our members' archives and is sought out by others for it.

Education and networking on a wide variety of topics of interest to state and territory archives occur at annual meetings, in monthly member webinars, online community exchanges, monthly calls for state archivists and virtual meet-ups for state archives staff.

Here's a summary of these activities:

- participants and more than 1,000 post-webinar recording views.

 Topics included advocacy for archives, member spotlights, replevin stories, AI and machine learning, approaches to electronic records transfers, and Story Maps as a tool for engagement and advocacy.

 Two new educational events the Building Archives Virtual Symposium and the SERI STEER Unconference drew a combined total of nearly 200 attendees. Most attendees reported that they anticipate folding concepts presented in these sessions into future strategic planning or in reframing current plans.

 CoSA and the National Archives collaborated on two webinars and four corporate sponsors presented ShopTalk programs.
- Annual Meeting: The 2023 meeting was held in conjunction with the Society of American Archivists in Washington, DC. The meeting was preceded by a successful Archives on the Hill event. CoSA members from 39 states and the District of Columbia met with NARA colleagues and corporate sponsors for robust Work Session conversations and the Business Meeting. Our thanks to <u>Ancestry</u> and <u>APPX</u> for sponsoring significant portions of the meeting and to <u>FamilySearch</u> for supporting the annual Awards Program.
- Electronic Records Day 10.10.2023: Messaging for this annual event reached more than 2,600 people on Facebook and had over 20,000 impressions on X. SERI committees produced a special webinar that attracted nearly 100 registrants and published the "Artificial Intelligence in the Archives" poster which is downloadable from the CoSA website. Thanks to a wide range of allied organizations and many state and territorial archives for supporting this important awareness effort!

Knowing that CoSA's members are challenged in recruiting and retaining qualified, diverse staff, we are committed to making space for archives leaders and staff to learn, share, and expand their potential. This includes developing and implementing programmatic initiatives that also speak to the broad public access of records.

Highlights include:

- State Electronic Records Initiative (SERI): Now in its twelfth year,
 <u>SERI</u> focuses on building organizational capacity around electronic
 records management, preservation, and access with ongoing
 digital capability assessment, topical webinars, guidance
 publications and reports, online communities of practice, and
 technical assistance.
 - ➤ The IMLS-funded <u>BACKER: Building Archival Capacity for Keeping Electronic Records</u> grant provides technical assistance, educational programming, and training to state and territorial government archives to strengthen their digital records preservation and accessibility capacities.
 - Managing Cross-Cultural Differences: As part of the BACKER project, consultant Helen Wong Smith is providing training and ongoing feedback to member agencies. An expanded web page featuring tools, templates, and a library of published resources is now available.
- Networking: an increasingly active set of <u>online communities</u>, including a new State Archives Job Board open to anyone interested in the field. CoSA also hosts monthly calls with state and territorial archivists and periodic virtual chats with archives staff.



FINANCIAL HIGHLIGHTS



As part of our efforts to achieve a sustainable future, CoSA underwent a significant change in our financial structure and practices during FY2023 to minimize necessary changes given future leadership changes. In addition to consolidating our various accounts for more robust remote access, we transferred our bookkeeping services to a national firm with a specific expertise in non-profit finances. This led to a full restructuring of our Chart of Accounts, which now aligns with generally accepted accounting practices and allows us more accurate tracking of our income/expenses alongside our budget and identified programs.

Several things to note regarding the associated charts:

- The numbers reflected on the charts are unaudited. CoSA will undergo two phases of account review: an
 internal process with our bookkeeping firm followed by our external independent audit. Audited
 financials are expected by Summer 2024 and will be shared with the membership according to the
 bylaws.
- In the past, CoSA has not tracked Fundraising activity; however, both the Executive Director and Communication and Development Coordinator spend a notable portion of their time engaged in securing funds from external sources for the organization. This work is intended to diversify our income sources and work towards a sustainable future.
- In July 2023, CoSA met jointly with the Society of American Archivists in Washington, DC. The negotiated revenue share is noted on our FY2023 Income. We are grateful for their generosity and fiscal acknowledgement for CoSA's contributions to the success of the July meeting. The SAA Council has since specified that they will no longer participate in revenue sharing activity at future annual meetings. In 2024, CoSA will be meeting independently in St. Louis, Missouri.

Special thanks are extended to Steve Murray, Treasurer (2022-2024), who assumed this role at the start of a complex time for CoSA's finances and has been a thoughtful advocate and leader for the Finance Committee, Board of Directors, and the CoSA community.
