State CIO Priorities for 2014 November 5, 2013

A. Priority Strategies, Management Processes and Solutions

Top 10 Final Ranking

- Security: risk assessment, governance, budget and resource requirements, security frameworks, data protection, training and evereness, insider threats, third party security practices as outsourcing increases, determining what constitutes "due cere" or "resonable"
- Consolidation / Optimization: centralizing, consolidating services, operations, resources, infrastructure, data centers, communications and marketing "enterprise" thinking, identifying and dealing with barriers
- Gloud Services: scalable and elastic IT-enabled capabilities provided "as a service" using internet technologies, governance, service management, inches provice particips management in commission of the provice porticips management in commission of the provice porticips management.
- Project and Portfolio Management: project management discipline, enterprise portfolio management (EPM), overgibt, portfolio review, IT investment/Management (ITIM), training/certification of staff, traceability to mission and strategy, scope management, execution
- Strategic IT Planning: vision and roadmap for IT, recognition by administration that IT is a strategic capability; integrating and influencing strategic planning and visioning with consideration of future IT innovations; aligning with Governor's policy agenda
- Budget and Cost Control: managing budget reduction, strategies for savings, reducing or avoiding costs, dealing with inadequate funding and budget constraints
- Mobile Services / Mobility: devices, applications, workforce, security, policy issues, support, ownership, communications, wireless infrastructure, BYOD
- Shared Services: business models, sharing resources, services, infrastructure, independent of organizational structure, service portfolio management, service catalog, marketing and communications related to organizational transformation, transparent charge back rates, utility based service on demand
- Interoperable Nationwide Public Safety Broadband Network (FirstNet): planning, governance, collaboration, defining roles, asset determination
- Health Care: the Affordable Care Act, health information and insurance marketplaces, health enterprise
 architecture, assessment, partnering, implementation, technology solutions, Medicald Systems (planning,
 retiring, implementing, purchasing), eligibility determination


B. Priority Technologies, Applications and Tools
