NHPRC OVERVIEW

- NHPRC office was closed from December 22-January 26
Failure to reach a budget agreement or CR
Result was the partial government shutdown (800K+)
- Staff was unable to assist anyone or work on any project
- Staff returned to work on January 28 & has been working hard to ensure that existing grants & upcoming grant opportunities are fully addressed
- Encourage SHRABs to send in news of successful regrants
- June 19 marks the 85th anniversary of the NHPRC

STATE BOARD GRANTS

- Impact of continuing resolutions and government shutdown
 - Awards delayed
 - Payments on current grants delayed
- Commission will offer two grant programs
 - Continue current programming grants of up to \$40,000 for one year and up to \$80,000 for two years
 - Add programming grants of up to \$12,000 for one year
 - Funding available for program increased to \$800,000

STATE BOARD GRANTS

- Grant announcement changes regarding applications

Demonstrate that all digitization projects will result in online access

Provide evidence of recent efforts or plans to identify needs of repositories and potential users

Explain outreach plans for expanding the public's understanding and use of records

Present information about efforts to reach out to underserved communities and address the issues of institutional advancement and sustainability

NEW GRANT PROGRAM

- Archives Collaboratives: Planning Grants
 - Plan collaboratives of three or more partners
 - Develop ideas and efforts that could be shared in order to enhance the capacity of small and underserved repositories
- Archives Collaboratives: Implementation Grants
 - Formally establish partnerships
 - Implement ideas and efforts created with planning grant funding

NEW GRANT PROGRAM

- State Board Participation in New Program

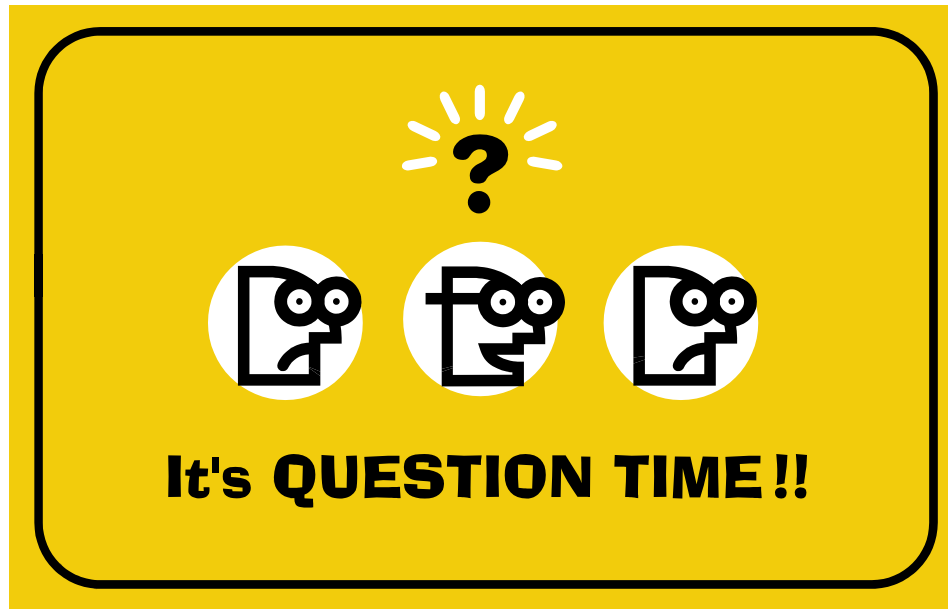
Spread the word about the program
